• The Chartered Organization Representative (COR) is the direct contact between the unit and the Chartered Organization. This individual is also the organization's contact with the District Committee and the Local Council. The chartered organization representative may become a member of the district committee and is a voting member of the council. If the chartered organization has more than one unit, one representative serves them all. The Chartered Organization Representative appoints the Unit Committee Chairman.





Chartered Organization Responsibilities (OH/IH and COR)

- Comply with its own, and BSA Policies
- Include Scouting as Part of its Overall Program for Youth and Families
- Appoint a Representative (COR)
- Committee of Parents and Others
- Provide a Secure Meeting Place
- Encourage Outdoor Experiences





Chartered Organization Representative's Duties (OH/IH and COR)

- Not an Honorary Position
- Head of Organization's Scouting Dept.
- Approve Financial Policies
- Liaison to District & Council
- Voting Member of District & Council

- Encourage Leader Training
- Promote Solid Programs
- Provide Enough Units for the Need
- Promote Recruiting Youth
- Encourage Youth Transition
- Assist in Charter Renewal
- Suggest Good Turns




